**Note 1 :** The Company has issued USD 110 MN Foreign Currency Convertible Bonds (FCCBs) which are convertible at the option of the Bondholder at a conversion price of Rs.93.8125 per Equity Share (INR67.4463 =US\$ 1.00 as on May 20 2016). Thereafter, the Company has issued a notice dated September 15, 2016 announcing adjustment to the Conversion Price of the Bonds in accordance with the terms and conditions of the Bonds and accordingly, the Conversion Price adjusted from the earlier price of INR 93.8125, to INR 92.16 w.e.f. September 14, 2016 and the number of shares underlying outstanding FCCBs were 8,05,02,311 of Rs. 1/- each.

**Note 2 :** The FCCB Committee has allotted 7,06,22,467 Equity Shares of Re. 1/- each on conversion of US \$ 9,65,00,000 aggregate principal amount of FCCB Bonds into Equity Shares till date.
