Thereafter, the Company has issued a notice dated September 15, 2016 announcing adjustment to the Conversion Price of the Bonds in accordance with the terms and conditions of the Bonds and accordingly, the Conversion Price adjusted from the earlier price of INR 93:8125, to INR 92.16 w.e.f. September 14, 2016 and the number of shares underlying outstanding FCCBs are 8,05,02,311 of Rs. 1/- each.

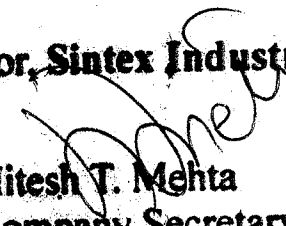
